(“TDS Telecom”), met with each of the following Commission personnel to discuss TDS Telecom’s Petition for Limited Waiver of 47 C.F.R. § 51.917(c), which was filed in the above-referenced proceedings:¹ Daniel Alvarez, Legal Advisor to Chairman Wheeler; Priscilla Delgado Argeris, Legal Advisor to Commissioner Rosenworcel; and Nick Degani, Legal Advisor to Commissioner Pai. The following day, on April 2, 2014, Mr. DeBroux and I met with the following Commission personnel to discuss the same topic: Rebekah Goodheart, Legal Advisor to Commissioner Clyburn; and Amy Bender, Legal Advisor to Commissioner O’Rielly.
